7 Handling and Storage

Precautions for Safe Handling:

Use of safe work practices are recommended to avoid eye or skin contact and inhalation of dust. Avoid dust formation. Avoid unnecessary contact with dusts and fibres by using good local ventilation and keeping the work area clean of dusts and fibres.
